  Answer: Both fully insured and self-funded proposals are being requested.
- **10. Question**: Under the wellness initiative, how much are the current dental / vision carriers contributing to these programs? Are these via credits included in the rates/fees or are they outside of the coverage costs?

Answer: The current vision carrier's wellness contribution has been \$5,000 each year for the past three plan years and is not built into the fee and rate structure.
