2023 Open Enrollment Overview

LACERS Open Enrollment is October 17, 2022 - November 17, 2022

LACERS will accept applications for health plan changes, addition of eligible dependents, and new enrollments from October 17, 2022, to November 17, 2022. If you do not want to change plans nor add dependents, you do not need to take any action; your current LACERS health coverage will continue for the upcoming 2023 plan year. However, you may want to review the Open Enrollment material to stay informed of your benefit options.

Review your 2023 Open Enrollment Health Plan Statement (a <u>snapshot</u> of your coverage in LACERS' system as of August 31, 2022) for your current coverage for 2023 premiums, subsidies, and deductions. If your plan changes were processed after August 31, 2022, or are a New Retiree/Survivor, please log into your MyLACERS account to view.

The overall 2023 health plan premium costs increased by approximately \$1.4 million, or 0.8% which is favorable against the benchmark of 7.5%. Rigorous negotiations by your LACERS team resulted in a \$2.4 million decrease from the initially proposed premiums. The carrier premium rate changes are:

- Anthem Blue Cross HMO and PPO, and Part B only HMO and PPO: 9.50%
- Kaiser Permanente HMO: 4.32%
- UnitedHealthcare Medicare Advantage HMO: 1.46%
- No premium increases for: Anthem Medicare Preferred PPO, Kaiser Senior Advantage, SCAN, Blue View Vision, and Delta Dental PPO and HMO

This year, the Open Enrollment meetings will be held live virtually. Meetings with our carriers (Anthem Blue Cross, Kaiser Permanente, SCAN, UnitedHealthcare, Delta Dental, and Anthem Blue View Vision), will include LACERS updates for the coming plan year, a presentation by each carrier, and question and answer sessions. Meetings will be held using Zoom video conferencing. If your computer/device has internet access and audio capabilities, you will be able to hear the presentations and view the material. If your computer does not have audio capabilities, or if you would prefer to just listen to the presentations, you may call in to hear the presentations.

Need Health Plan Forms?

If you wish to make health plan changes or add dependents, you must submit the appropriate forms to LACERS by November 17, 2022. Health plan enrollment and family account change forms are available in the Forms section of the LACERS website at www.lacers.org/forms-info-sheets or upon request by emailing LACERS.Health@lacers.org or calling LACERS at (800) 779-8328.

Prescription Medications On Hand

If making changes to your health plan coverage, please make sure that you have enough medication to cover at least the first two weeks of January 2023. Such preparation will ensure you have the medications you need should there be a delay in switching from one carrier to another.

Your Health Plan Decisions Will Be Effective January 1, 2023

The health plan changes you make during this Open Enrollment period are effective for the entire plan year from January 1 through December 31, 2023. New deductions reflecting your health plan changes will first appear on your December 31, 2022, retirement check.

After this Open Enrollment period, you may not change your health plan again until the next Open Enrollment period in October 2023 unless you have a qualifying event, such as a family status change (birth, new relationship – marriage or domestic partnership) or new residence outside your selected plan's service area. Please see pages 6-8 of the 2023 Health Benefits Guide for more details. A Retired Member turning age 65 is also a qualifying event as enrollment in Medicare is required. Please see pages 9-10 of the Guide for more details as well as page 11 for information regarding the assessment of Income-Related Monthly Adjustment Amounts (IRMAA) that may affect you.

Your Address On File With LACERS

Be sure that LACERS has your current home address. If you have moved or plan to move, please contact LACERS at least thirty (30) days prior to moving because changing your home address can impact your health coverage.

LACERS Turns 85

In 1937, the Los Angeles City Charter established the Los Angeles City Employees' Retirement System (LACERS) as a retirement trust fund for the purpose of providing the civilian employees of the City of Los Angeles, a defined benefit retirement plan inclusive of service retirements, disability retirements, and survivor benefits. The Retiree Health Insurance benefit was added in 1973.
