



**NOTICE OF ELECTION**

**2025 ELECTION FOR THE RETIRED MEMBER OF THE BOARD OF ADMINISTRATION  
OF THE LOS ANGELES CITY EMPLOYEES' RETIREMENT SYSTEM (LACERS)  
FOR A FIVE-YEAR TERM BEGINNING ON JULY 1, 2025 AND ENDING ON JUNE 30, 2030**

An election will be held on Friday, April 11, 2025, to select the Retired Member of the LACERS Board of Administration. If you are a LACERS member who has retired on or prior to March 10, 2025, a ballot packet will be mailed to your mailing address starting on Wednesday, March 19, 2025, containing voting instructions, candidate statement of qualifications, and an official ballot to be executed in accordance with established voting procedures. Below is a sample of the official ballot containing the names of each qualified candidate.

If you are a newly retired member of the System, who have become eligible on or after March 10, 2025, and wish to vote, you must obtain a Certificate of Eligibility to Vote from LACERS, verifying their eligibility to vote. The LACERS Office is located at 977 N. Broadway, Los Angeles, CA 90012, Monday to Friday between the hours of 7:00 a.m. and 4:00 p.m. You must present yourself to the Office of the City Clerk – Election Division (Election Division) with the Certificate of Eligibility to Vote to obtain an official ballot no earlier than Friday, April 4, 2025, and no later than 5:00 p.m., on Friday, April 11, 2025. The Election Division is located at 555 Ramirez Street, Space 300, Los Angeles, CA 90012, open Monday to Friday between the hours of 8:00 a.m. and 5:00 p.m.

Ballots may be deposited in any U.S. postal mailbox and must be received not later than 5:00 p.m., on Friday, April 11, 2025, the day of the election. Voters may also choose to deliver their ballot in person not earlier than Friday, April 4, 2025, and not later than 5:00 p.m., on Friday, April 11, 2025, by using the drop box or mail slot, located at the Election Division.

Any eligible voter who has inadvertently damaged, spoiled, lost or did not receive an official ballot may obtain a replacement ballot upon filing an Affidavit of Loss/Non-Receipt with the Election Division. The replacement ballot can be requested in person at the Election Division or by contacting (213) 978-0444 or emailing Clerk.ElectionAdmin@lacity.org.

Voted ballots must be received by the Election Division no later than 5:00 p.m., on Friday, April 11, 2025. The ballots will be opened and tallied on Tuesday, April 15, 2025, at the Election Division starting at 9:00 a.m., in the presence of candidates and up to two (2) observers designated by each respective candidate, if so requested. The candidate who receives at least 50% plus one of all votes cast shall be declared elected to the position of Retired Member of the Board for the five-year term ending June 30, 2030. If no candidate receives a majority of all votes cast, a run-off election will be conducted on Friday, May 23, 2025, for the two candidates receiving the highest number of votes.
