What You Need to Know






- Open Enrollment will be held October 15 –
 November 17.
- This is the time to enroll in a plan, change plans, or add dependents. After Open Enrollment, this can only be done if you have a qualifying event.
- Changes made during the Open Enrollment period will be effective January 1, 2026.



Health Plan Renewals

- Estimated overall premium cost for LACERS' medical, dental, and vision plans will increase by 8.35%.
- Changes for 2026:
- **SCAN Health Plan**: Newly available in the California counties of Kings, Sacramento, San Joaquin, Placer, Tulare, and Yolo.
- Anthem Medicare Preferred: The preferred brands for Continuous Glucose Monitors
 have changed to Freestyle and Dexcom, and Abbott is replacing LifeScan for preferred
 diabetic testing supplies. Access2Care will merge under Medicare Transportation
 Management, Inc. (MTM).
- UnitedHealthcare: Effective December 31, 2025, the Emergency Response System (PERS)
 benefit with Lifeline will be discontinued. Retirees will have the option to convert to
 private pay or discontinue services.

2026 Subsidies and MPRP Reimbursements





2026 Subsidies and MPRP Reimbursements

- Because the 2026 Kaiser Permanente HMO two-party premium will increase by \$89.26, the Board has the authority to increase the maximum medical subsidy for Retirees under 65 or with Medicare Part B only, by that amount, from \$2,318.58/month to \$2,407.84/month.
- This is the same for the Medical Premium Reimbursement Program (MPRP)
 maximum reimbursement.
- The maximum dental subsidies, determined by the Active dental subsidies, will be \$42.93/month for the PPO plan and \$15.70/month for the HMO plan.




Income-Related Monthly Adjustment Amount (IRMAA)





Income-Related Monthly Adjustment Amount (IRMAA)

- IRMAA is a surcharge on top of the basic/standard Medicare Part B and D premium rates.
- Medicare enrollees whose Modified Adjusted Gross Income exceeds a certain threshold may be assessed an IRMAA
- Non-payment and partial payments of IRMAAs and/or allowing your Medicare premium payments to lapse will lead to the cancellation of your LACERS medical plan coverage.
- Please contact the Centers for Medicare & Medicaid Services (CMS) for more information.

Reminders

- If you are planning on moving in the future, keep in mind that your plan may not be available in your new zip code so you may only have emergency services available. Please contact LACERS at least 30 days before you move.
- If you are changing plans, be sure to check your new plan's prescription formulary and to get your prescriptions filled before your effective date to allow time for your new plan benefits to get set up.
- If you are changing plans, please consult with your physicians on whether they accept the new plan and are accepting new patients.
- If you or your dependent will be turning 65 soon, remember that you are required by the Los Angeles Administrative Code to enroll in Medicare Part B and if you are eligible for Medicare Part A at no cost, you are required to enroll in Part A as well.
