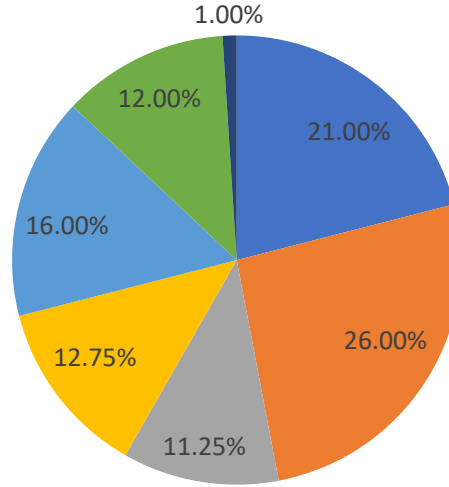

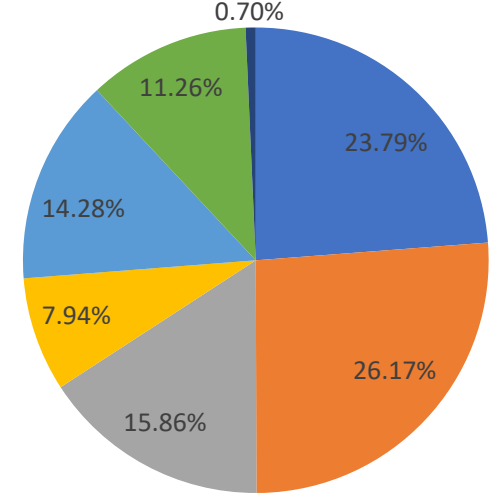

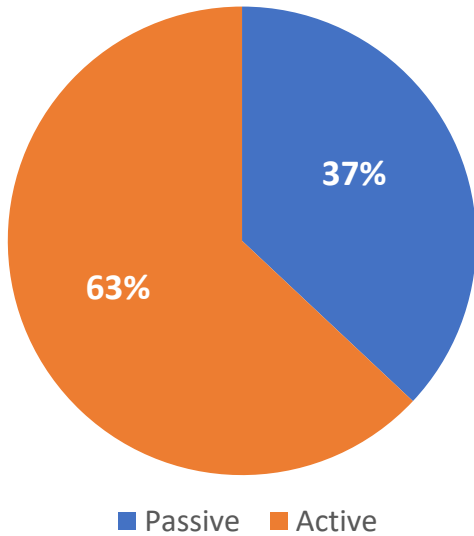


### Actual Allocation



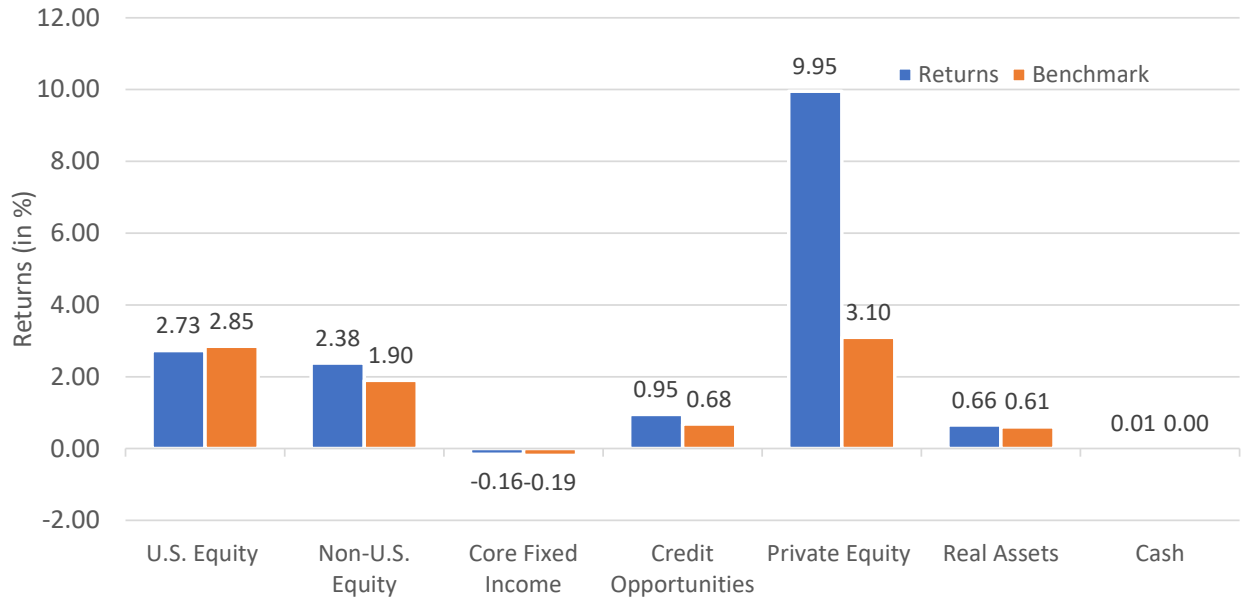

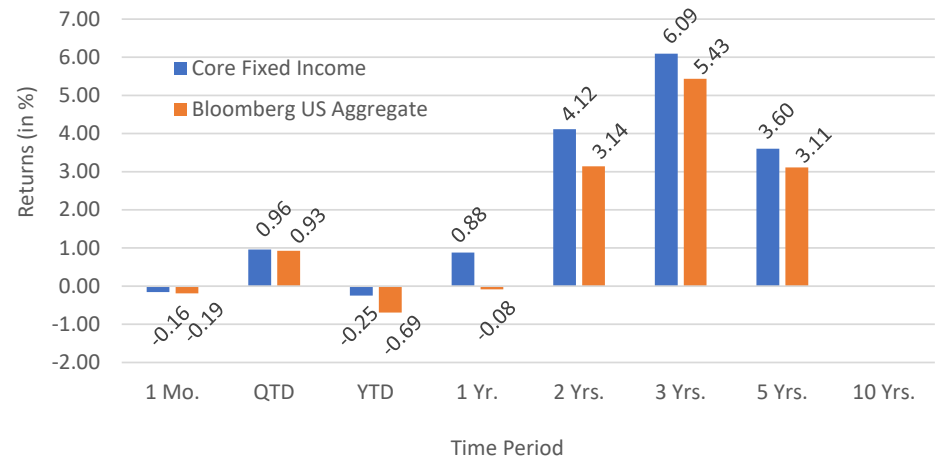

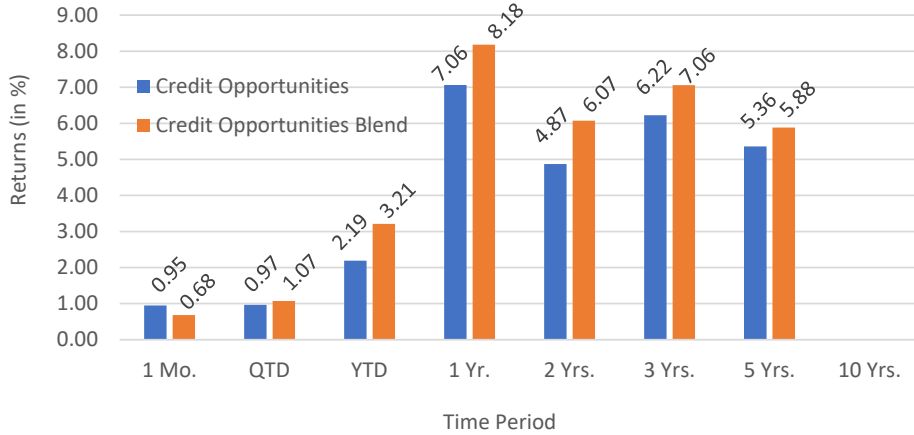
