

## NOTICE OF ELECTION

### **2020 ELECTION FOR THE RETIRED MEMBER OF THE BOARD OF ADMINISTRATION OF THE LOS ANGELES CITY EMPLOYEES' RETIREMENT SYSTEM (LACERS) FOR A FIVE-YEAR TERM BEGINNING ON JULY 1, 2020 AND ENDING ON JUNE 30, 2025**

Below is a sample of the official ballot containing the names of each qualified candidate. If you are a LACERS member who has retired on or prior to March 18, 2020, a ballot packet will be mailed to your mailing address. LACERS members retired after March 18, 2020 who wish to vote must obtain a certificate verifying their eligibility to vote by contacting LACERS at (800) 779-8328. Members may present the certificate to the Office of the City Clerk – Election Division in order to receive a ballot by calling (213) 978-0440. The Office of the City Clerk – Election Division will provide voting instructions, an official ballot, and a postage paid envelope to be executed according to established procedures.

The Office of the City Clerk, Election Division is closed to the public until further notice as a precautionary measure to help slow the spread of the Coronavirus (COVID-19). Please call (213) 978-0440 to set up an appointment for the following:

1. If you wish to personally deposit your voted ballot, beginning on April 14, 2020 and not later than 5:00 p.m., on Tuesday, April 21, 2020.
2. If you damage, spoil, lose or did not receive your official ballot and wish to obtain a replacement ballot, and upon filing an Affidavit of Loss/Non-Receipt form.

Ballots marked in accordance with the voting instructions may be deposited in any U.S. postal mailbox in time to be received by the Office of the City Clerk – Election Division not later than 5:00 p.m., on Tuesday, April 21, 2020.

Ballots will be opened and tallied on Thursday, April 23, 2020 at 9:00 a.m., in the Office of the City Clerk – Election Division. The candidate that receives at least 50% plus one of all votes cast shall be declared as the elected Retired Member of the Board for the term ending June 30, 2025. In the event that no candidate receives a majority of all votes cast in the initial election, a run-off election shall be conducted on Thursday, May 28, 2020 for the two candidates receiving the highest number of votes.
