**NOTICE OF ELECTION**

**2025 SPECIAL ELECTION FOR EMPLOYEE-MEMBER OF THE BOARD OF ADMINISTRATION  
OF THE LOS ANGELES CITY EMPLOYEES' RETIREMENT SYSTEM (LACERS)  
FOR AN UNEXPIRED TERM ENDING JUNE 30, 2028**

A special election will be held on Friday, September 26, 2025, to select the Employee-Member of the LACERS Board of Administration. If you are an active LACERS Member who attained membership prior to August 24, 2025, a ballot packet will be mailed to your mailing address starting on Wednesday, September 10, 2025, containing voting instructions, candidate statement of qualifications, and an official ballot to be executed in accordance with established voting procedures. Below is a sample of the official ballot containing the names of each qualified candidate.

If you are a new employee who became an active LACERS Member on or after August 24, 2025, and wish to vote, you must obtain a Certificate of Eligibility to Vote from the City Personnel Department, Employment Verification Section, 700 East Temple Street, Los Angeles, CA 90012. You must present yourself to the Office of the City Clerk – Election Division (Election Division) with the Certificate of Eligibility to Vote to obtain an official ballot no earlier than Friday, September 19, 2025, and no later than 5:00 p.m., on Friday, September 26, 2025. The Election Division is located at 555 Ramirez Street, Space 300, Los Angeles, CA 90012, open Monday to Friday between the hours of 8:00 a.m. and 5:00 p.m.

Ballots may be deposited in any U.S. postal mailbox and must be received not later than 5:00 p.m., on Friday, September 26, 2025, the day of the election. Voters may choose to deliver their ballot in person not earlier than Friday, September 19, 2025, and not later than 5:00 p.m., on Friday, September 26, 2025, by using the drop box or mail slot, located at the Election Division.

Any eligible voter who has inadvertently damaged, spoiled, lost or did not receive an official ballot may obtain a replacement ballot upon filing an Affidavit of Loss/Non-Receipt with the Election Division. The replacement ballot can be requested in person at the Election Division or by contacting (213) 978-0444 or emailing Clerk.ElectionAdmin@lacity.org.

Voted ballots must be received by the Election Division no later than 5:00 p.m., on Friday, September 26, 2025. The ballots will be opened and tallied on Wednesday, October 1, 2025, at the Election Division starting at 9:00 a.m., in the presence of candidates and up to two (2) observers designated by each respective candidate, if so requested. The candidate who receives a plurality of all votes cast shall be elected to the position of Employee-Member of the Board for the unexpired term ending June 30, 2028.
